# Sustainability and Innovation Soil and Groundwater Remediation Research Competition Application guide

## I. Purpose

The Sustainable Development Goals (SDGs) proposed by the United Nations have become the global action direction to promote sustainable development. This competition sets "<u>sustainable innovation in soil and groundwater</u>" as the topic, through the ASEAN National Soil and Groundwater forum, to inspire reflection and thinking of environment protection for ASEAN National and Taiwan postgraduate students (including master and doctoral). Students to take action on soil and groundwater protection and propose practical solutions for soil and groundwater problems. Through the practical application of the competition, participants are hoped to work towards sustainable development and cultivate soil and water talents jointly in Taiwan and ASEAN countries.

- A. Organizer: The Soil and Groundwater Remediation Fund Management Board
- B. Implementer: The Taiwan Environmental Sustainable Development (TESD) Foundation

## **III.**Competition description

Participating teams in the "Sustainable Innovation Soil and Groundwater Remediation Research Competition" must participate in a series of "Soil and Groundwater Forum and on-site Visiting for ASEAN students" event organized by the Environmental Protection Administration. After understanding the soil and waterrelated policies and practical technologies, focusing on the topic of "<u>sustainable</u> <u>innovation in soil and groundwater remediation thinking</u>", and propose (1) research aspects: practical solutions for innovative technologies or (2) management aspects: environmental protection policies and strategies are proposed as the results. Results must be presented in the form of actual finished product presentations or briefings for scoring consideration by the competition committee.

## **IV.** Participants and qualifications

- A. The team must participate in one of the Northern and Southern events "Soil and Groundwater Forum and on-site Visiting for ASEAN students" activities organized by The Soil and Groundwater Remediation Fund Management Board of the Environmental Protection Administration of the Executive Yuan.
- B. When registering or during in the competition, you must have the qualifications of foreign graduate students from ASEAN countries or Taiwanese graduate students (including master and doctoral) from public and private colleges and universities in Taiwan.
- C. Participants must form a "joint team" to register. The team must include the following members: At least half of the members must be foreign graduate students from ASEAN countries, and at most two Taiwanese graduate students. Teams can be formed across schools or departments and elect one captain and sign up. Each person is limited to participating in one team.

# **VI.** Competition rules

A. Competition Committee:

The ASEAN Partnership Strategy Group (representatives from industry, government, and academia), composed of the projects, will form a committee of three members and conduct a two-stage scoring of the preliminary round and final.

- B. Scoring criteria :
  - 1.Preliminary round: The participating teams upload the Preliminary round documents within the regulated time, and the materials will be reviewed by (1) theme suitability, (2) Innovation in Proposal, and (3) Team execution and feasibility. And the top 10 teams will be selected by the committee to enter the finals.
  - 2.Finals: The **briefing presentation** or **actual products** provided by the teams as the main final content. The final review will focus on (1) theme suitability, (2) Innovation in Proposal, (3) method, (4) feasibility, and (5) Presentation (the presentation time is limited to 10 minutes, the committee will ask questions and reply within 10 minutes) for scoring. The Awards Ceremony of the finals will announce winner lists and awards in a "New Southbound National Forum" by the organizer.

## VII. Submission of documents

- A. <u>Preliminary round documents</u>: Please submit the documents to the URL: https://forms.gle/d1BPJZQ7ajiY6c4C7 within the submission period. The limit is no more than 5 pages. Please submit both your Word file and a PDF file named by Subject, Institution and Team Name (e.g. Soil and groundwater\_ CYCUEE\_BEE Team). <u>The documents submitted in the preliminary round</u> <u>are as follows</u>:
  - 1.Origin
  - 2.Content proposal for sustainable innovation of soil and groundwater remediation thinking
  - 3.Specific methods (1) Research aspect: practical solutions for innovative technologies or (2) Management aspect: environmental protection policy strategies.
  - 4.Expected goals and benefits
- B. Finals: Please provide a <u>briefing presentation</u> or <u>actual finished products</u> on the day of the competition.

## VIII. Scoring criteria

- A. The ranking method is adopted for the selection. The committee should score each item separately, and get the total score. The total score will be converted into rank.
- B. If the rank is the same, the score item of "theme suitability" ranking will be the basis to judge the winner; if the ranking is the same again, the score item of "innovation-related" will be the basis to judge.

### IX. Subsidy and Awards

- A. - B. Awards:

"The Sustainable Innovation Soil and Groundwater Remediation Technology Research Competition" awards are as follows and will be presented at the New Southbound National Forum.

- 1.Outstanding Prize (1 team): a gift certificate or equivalent prize (NTD 50,000) and a certificate of award.
- 2.Wonderful Prize (1 team): a gift certificate or equivalent prize (NTD 20,000) and a certificate of award.
- 3.Excellent Prize (1 team): a gift certificate or equivalent prize (NTD 10,000) and a certificate of award.
- 4.Superior Prize (2 teams): a gift certificate or equivalent prize (NTD 5,000) and a certificate of award.

#### X. Precautions for participation

- A. Team names and team members cannot be modified or replaced after the registration deadline; the organizer reserves the right to refuse to accept any additions to the list of team members after the finalists are selected or the winners' list is announced.
- B. When registering, please fill in your frequently used email address and contact number (such as mobile phone number). Important information about the competition will be sent to this mailbox in the future, including the finalist selection and the notification of the award ceremony.
- C. To protect the rights and obligations and intellectual property rights of all

participating teams, please fill in the "<u>Authorization Consent Form</u> and Intellectual Property Rights". (such as Annex I and Annex II). Provide organizers and executive units to promote soil and groundwater protection and permanent non-profit use.

- D. Entries should conform to the subject of the call for submissions and the acceptance specifications, should not violate laws, infringe or impede public order and good morals, and should be limited to works that have not been published publicly (the definition of "publicly published": the entries must not have been published in any form, published in various The works of the media, including all or part of the content of the works, shall not be disclosed to the public in print, online, social media or in other ways, nor shall they be repeatedly submitted or contested on various media.
- E. Those who plagiarize or copy others, infringe others' copyrights or whose copyrights are unknown, participate in other competitions at the same time, and do not meet the relevant regulations of this selection, if they are reported and verified to be true, the organizer has the right to revoke the termination qualification. It will be recovered. If there is any violation of the law, all legal responsibilities shall be borne by the participating teams themselves.
- F. Entries include references to other people's works or materials. Please explain in detail or indicate the source.
- G. All materials or works submitted during the competition will not be returned. If necessary, please back up the team.
- H. The recipient of the prize is an individual residing in the Republic of China, and the prize money shall be withheld 10% of the income tax in accordance with the provisions of the Income Tax Law for various types of income withholding rates. Those whose tax amount is less than NT\$2,000 will be exempted from withholding; the recipient of the prize is a foreign national and if they stay in the territory of the Republic of China for more than 183 days, 10% of the income tax shall be withheld from the winnings and prizes according to the income tax withholding rate standard stipulated in the Income Tax Law. Regardless of the value of the prizes, 10% of the tax shall be withheld from the winnings; Prize recipients are individuals who are not residing in the Republic of China (i.e., nationals and foreigners who have resided in the Republic of China for less than 183 days). Regardless of the value of the prize, a 20% tax will be withheld on the winnings.
- I. The winning team will send a representative from each team to fill in the winning

receipt, and the organizer will provide the following two information off to the captain by email two weeks ago (1) The consent form of the award representative (or the replacement of the award representative consent form) (such as Annex III) and (2) Receipt of the award (such as Annex V), please print out and sign the award receipt and send it to 32023桃園市中壢區中北路200號生物科技館110室戴欣姿 小姐收. If the representative is unable to claim the prize for any reason, other members of the team will jointly sign and agree to replace the representative to claim the prize.

### XI. Others

- A. If the selected team is unable to participate in the competition review for some reason, the organizer will notify the alternative team to participate in the review.
- B. The finals for the teams that were not selected, the organizer will provide a certificate of participation for encouragement.
- C. The organizer reserves the right to change and explain the program content and event schedule. Matters not covered shall be handled according to relevant laws and regulations; those participating in this competition agree to accept all specifications.
- D. The Central Epidemic Command Center stated on April 15, 2022, that the threat of the new variant of Omicron has not yet eased as the local epidemic continues to increase, and the imported cases are still high. In order to protect the health of the employees and the participants, we need to strengthen the third dose of the COVID-19 vaccine for high-risk places (domains).
  - 1.Participants (including staff and the public) who meet the vaccination age must complete the COVID-19 vaccine booster (third dose) vaccination. Please provide proof of receiving the third dose of the vaccine, especially for those who were exposed to activities that include contact with unknown people or activities, such as religious activities (passing around the border, participating in incense groups), group tours (contracted by travel agencies), and participating in tours where members belong to unspecified people, gyms and eight major industries (implemented since April 1).
  - 2.If the person is evaluated by a doctor and issued a certificate that the COVID-19 vaccine is not recommended (for example case where the doctor has confirmed that there are contraindications to all COVID-19 vaccines authorized for use in China or serious adverse reactions have occurred, therefore the vaccination is not

recommended), please provide the issuance certificate that the vaccine cannot be administered. Also, provide a photo of your proof of the negative antigen rapid screening (including household rapid screening) 3 days before the day of the event. The proof must include images of the test result of the reagent, the test date, and the name.

3. The regulations of participation in activities will be adjusted in accordance with Central Epidemic Command Center.
